

WHAT WE'LL DO TO GET THERE!


STRATEGIES:


Review and synthesize transportation planning efforts with housing goals, strategies, and recommendations.



Total Exceedances (March - October)




Monitors where exceedances occurred:

- These 3 monitors have the highest 3-year average annual AQI.






**Figure 2. Maximum Monitor Design Values
